On the **91st** day, in the year of **Yahweh**, six thousand and twenty, translation **18th** day of **June**, two thousand and eighteen, at 7:00 Universal Time -6, the American Nationals for the Government of The United States of America, and all other interested persons convened a meeting for the assembly, identified as **20180618-SOS-OAR**.

Official Assembly Record

BE IT RESOLVED, that a motion was carried by the National assembly to Accept and Acknowledge the transfer of the Human Rights Tribunal International from the reign of the heavens society Temple back to the National Government of The United States of America; and

FURTHER BE IT RESOLVED, all the obligations and enforcement of the Law of Nations in addition to the Universal Declaration of Human Rights shall be transferred to the Human Rights Tribunal International for the Government of The United States of America; and

BE IT RESOLVED, that General Post Master, Kevin Lloyd Lakes accepts and acknowledges to stand as Chief International Notary for the International Notaries serving on the Human Rights Tribunal International; and

BE IT RESOLVED, there were no objections by the National assembly to transfer **International Arrest Warrant against Virgo Triad** to the Human Rights Tribunal International for the Government of The United States of America; and

BE IT RESOLVED, that a motion was carried by the National assembly to cancel the above referenced International Arrest Warrant to a violation of the Universal Declaration of Human Rights Article 3 wherein it reads:

Article 3- Right to life

- *Everyone has the right to life, liberty and security of person.; and*

BE IT RESOLVED, that in accordance with the Law of Nations, there was no objection by the National assembly that the Department of Transportation for the Government of The United States of America shall be reclassified under the International Classification of **Public Utilities**; and



FURTHER BE IT RESOLVED, the above referenced International Classification will include the Universal Declaration of Human Rights Preamble 2nd paragraph.

Wherein it reads:

Whereas disregard and contempt for human rights have resulted in barbarous acts which have outraged the conscience of mankind, and the advent of a world in which human beings shall enjoy freedom of speech and belief and freedom from fear and want has been proclaimed as the highest aspiration of the common people,

BE IT RESOLVED, there were no objections by the National assembly to transfer the following cases to the Human Rights Tribunal International for the Government of The United States of America:

- **International Arrest Warrant – David Hogg**
- **International Arrest Warrant – ANTIFA; and**

BE IT RESOLVED, that a motion was carried by the National assembly to **define human rights violations as war crimes; and**

BE IT RESOLVED, that a motion was carried by the National assembly to amend a motion passed on June 11, 2018, wherein the motion reads as follows:

***BE IT RESOLVED**, there were no objections by the National assembly to classify private companies that have hijacked the Public Highways as a war crime; and*

to the following:

BE IT RESOLVED, there were no objections by the National assembly to classify private companies that have hijacked the freedom of communication under privately owned Public Utilities Commission as a human rights violation; and

BE IT RESOLVED, there were no objections by the National assembly to **adopt the Legal Abuse Syndrome** for use by the Human Rights Tribunal International for the Government of The United States of America; and

BE IT RESOLVED, there were no objections by the National assembly for the following International Notaries to serve on the Human Rights Tribunal International for the Government of The United States of America;

- **David Brian Smith – International Notary**
- **John Francis Patrick O’Sullivan II- International Notary**
- **William Ralph Davidson – Lead International Notary – Alternate**

BE IT RESOLVED, there were no objections by the National assembly for General Post Master, Cheryl Wiker to assist the office of the Clerk for the General Post Master Council; and



WHEREAS, the National assembly of General Post Masters have addressed all issues and resolutions on the agenda file name 20180618-Agenda for National assembly;

BE IT RESOLVED, the meeting for the assembly adjourned on the **91st day, in the year of Yahweh, six thousand and twenty, translation 18th day of June, two thousand and eighteen, at 9:20 Universal Time -6** to re-convene at a future date certain.
