### Legal Tender for Debts Public and Private Act of 2016



By the authority of the faith of the assembly of American Nationals, in Union under the Law of Nations, and all Acts, petitioned, accepted and acknowledged by the current United States, in Congress assembled, are hereby ordained for the safety and security of our posterity, enact the following:

### SUBJECT MATTER OF THE ENACTMENT

The Legal Tender for Debts Public and Private Act of 2016 is intended to relieve the people within foreign jurisdictions of multiple human rights abuses and violations thereby relieving any organization of any human rights violations in its time of emergency, and

BE IT ENACTED, by the United States, in Congress assembled, **Legal Tender for Debts Public and Private Act of 2016, IS HEREBY ESTABLISHED, PUBLISHED AND ACKNOWLEDGED** on this 170<sup>th</sup> day, in the year of Yahweh, 6018,

### REGULATIONS-PENALTIES OF THE ACT

**1:** The United States, in Congress assembled hereby omits the following paragraph from the Declaration of Value as amended published by the office of the Treasury for the Government of The United States of America on 08-27-2016;

*IT IS DECLARED*

*, that the “National Currency” term on the current Continental Dollar shall be amended to read “Continental Dollar” on the money of the Government of The United States of America, any and all issuance with the term “Continental Currency” shall have the same effect as if the “Continental Currency” term read “Continental Dollar”. The aforementioned change shall be amended on future issuances of the Continental Dollar, and*

**2:** The office of the Treasury for the Government of The United States of America and all other offices under it shall have regulatory authority over the Legal Tender for debts public and private disaster relief program occurring throughout the world and within the United States of America, and

**3:** Any and all promissory notes wherein the maker is also classified as a borrower shall be declared trustee of the borrowers promissory note signed within the United States of America, and

**4:** The trustee of the promissory note shall have the authority to sign a new promissory note under this act for full discharge of all interest obligations attached to the note and mortgage agreement within the United States of America. Part 4 shall relieve the United States of America of liability for the creation of homelessness which is a recognized human rights violation, and

**5:** The trustee of the new promissory note signed within The United States of America and the States of the Union shall enjoy the benefit of full discharge of the promissory note under this act with a 1.00 dollar silver certificate printed within the United States of America or 1.00 Continental Dollar (Lawful Money/Full Title) of equal value of the 1.00 dollar silver certificate. Once discharged, the Continental Public Bank shall declare the balance of accounts settled wherein the former borrower shall be known as

**6:** All American Nationals shall have the privilege of being paid in Continental Dollars operating under the Legal Tender for debts public and private act of 2016 without recourse of violating any other part of the Articles of Confederation, as amended August 5th, 2015, and
