Letter of Acceptance and Acknowledgement as amended on 06-17-2018 from May 2nd, 2014,

Wherein does it read on May 2nd, 2014,

In Honor of Eleanor Roosevelt Letter of Acceptance and Acknowledgement of office for The Supreme Court of the Confederacy of The United States of America Human Rights Tribunal We, The General Post Master Council, together and separately accept and acknowledge the obligations of the Universal Declaration of Human Rights and that The Supreme Court of the Confederacy of The United States of America Human Rights Tribunal has been defined as an Article 8 court for peaceful settlement of disputes in accordance with the obligation hereby accepted and acknowledged.

Amended by the Articles of Confederation as amended August 5th, 2015 in Article VII, section 7.1 paragraph B:

(b) Furthermore, if the dispute cannot be settled in the office of peaceful settlement of disputes, the American Nationals, shall have the right to follow the Judicial process of the Government of The United States of America which consist of: The office of peaceful settlement of disputes, the General Post Master Council, the Human Rights Tribunal, the War Crimes Tribunal and the National assembly which are all courts of law, equity and Universal Jurisdiction, and

So therefore, by the authority vested in this office by the National assembly for the Government of The United States of America, the amendment of the Articles of Confederation are hereby accepted and acknowledged by the office of the Chief Judge of the General Post Master Council and brought forward to the present time, and
