ARTICLES OF IMPEACHMENT

IN THE MATTER OF: Impeaching, Stuart Andrews Ronaldson, office of the Governor for the Government of The United States of America, for high crimes and misdemeanors.

Authority: Article 5.6

(j) Judgment in Cases of Impeachment shall not extend further than to removal from Office, and disqualification to hold and enjoy any office of Honor or Trust under The United States of America: but the Party convicted shall nevertheless be liable and subject to Indictment, Trial, Judgment and Punishment, according to Law of the Government of The United States of America, and

IN ASSEMBLY

The North American National Party has submitted the following Articles of Impeachment;

RESOLUTION

Impeaching, Stuart Andrews Ronaldson, office of the Governor for the Government of The United States of America, for high crimes and misdemeanors, and

Resolved, that Stuart Andrews Ronaldson, office of the Governor for the Government of The United States of America, is impeached for high crimes and mis-demeanors and that the following articles of impeachment are exhibited to each member of the North American National Party for a vote to withdraw each members vote as of December 1st, 2017:



Article I

In his conduct while holding the office of the Governor for the Government of The United States of America in violation of his oath to the Articles of Confederation, as amended August 5th, 2015 and his oath to the office of General Post Master has prevented, obstructed and impeded the administration of justice in that:

Knowing that overwhelming evidence was being held in evidence of high crimes and possible treason, failed to retrieve said evidence and present the evidence to the National assembly, and

Article II

Knowing that the evidence was in existence started a campaign of smearing the office holder holding the evidence in various ways in an effort to discredit the office holder so that all evidence would be rendered moot, and

Article III

Knowing that the office holder was holding said evidence, threatened the appointed position of the office holder in order to remove said office holder from office in an effort to hide the evidence, and

Article IV

Knowing the evidence existed, attempted to pass two acts in the United States, in Congress assembled that would directly impede the evidence from ever coming to the fore front and be presented to the National assembly for a decision as to whether to send the evidence to the General Post Master Council for the Government of The United States of America for charges and trial, and

Article V

The pattern of behavior leading to the conclusion is that he continued to ignore evidence of possible treason, high crimes and international crimes of trafficking in persons, human trafficking, exile of American Nationals and residents, theft of Government property, capturing of the National flag in an act of war, capturing of the American National Union of The United States of America seal in an act of war, and failure to address the conduct of the perpetrator while said perpetrator consistently impeded any form of correction of the crimes with verbal violence and manipulation of rules and chain of command. While the evidence was being held and waiting to be presented to the National assembly, he continued to avoid any form of conversation of said evidence, and colluded with the perpetrator to continue a pattern of quashing any evidence that was required to be presented to the National assembly, further, he continued to impede the delivery of the mail to avoid the perpetrator from being served, and



In all of this, Stuart Andrews Ronaldson, office of the Governor for the Government of The United States of America has acted in a manner contrary to his trust as Governor and subversive of the Articles of Confederation as amended August 5th, 2015, to the great prejudice of the cause of law and justice and to the manifest injury of the General Post Masters of the Government of The United States of America, and

Wherefore, Stuart Andrews Ronaldson, office of the Governor for the Government of The United States of America, by such conduct, warrants impeachment and removal from office.
