INTERNATIONAL WAR CRIME CLAIM

The Government of The United States of America hereby publishes this International War Crime Claim against the internal revenue trust within one of the United States territories.

The Government of The United States of America hereby lodges this International War Crime Claim within the records of the International Community by publication of record.

Narrative:

The internal revenue trust within one of the United States territories is requiring a Social Security Number status (SSN) in order to receive basic needs, mainly food, water, shelter and clothing.
