On the 170<sup>th</sup> day, in the year of Yahweh, six thousand and eighteen, translation 5<sup>th</sup> day of September, two thousand and sixteen, at 7:00 Universal Time -6, the American Nationals for the Government of The United States of America, and all other interested persons convened a meeting for the assembly, identified as 20160905-SOS-OAR.

### Official Assembly Record



**BE IT RESOLVED**, that the Continental Dollar currency is hereby recognized as Legal Tender for debts public and private within the Government of The United States of America in addition to being traded as full title currency and lawful money within and without the Government of The United States of America, and the Continental Dollar is further recognized by the Government of The United States of America as Legal Tender for debts public and private in all foreign jurisdictions in addition too being traded as lawful money in foreign jurisdictions. In addition to the aforementioned recognition, the Government of The United States of America reserves the right to collect and retain all taxes collected when taxing the Continental Dollar currency as Legal Tender for debts public and private in foreign jurisdictions. The legal tender for debts public and private shall be issued by the Government of The United States of America under the classification of foreign disaster relief whereby the Government of The United States of America retains full regulatory authority over the foreign disaster relief program; that being the Legal Tender for Debts Public and Private Act of 2016, and

**FURTHER BE IT RESOLVED**, that the Government of The United States of America will accept all foreign currency's dollar for dollar, value for value or in its exchange rate in the Continental Dollar currency exclusively in its capacity as Legal Tender for debts public and private, and

**FURTHER BE IT RESOLVED**, that the Government of The United States of America hereby abates as a public nuisance and notwithstanding, the declaration made by Bobby J. James Postmaster of the private company known as United States Postal Service at HATTIESBURG POST OFFICE FORREST COUNTY, MISSISSIPPI that the Continental Stamp is "fake" postage, and

**FURTHER BE IT RESOLVED**, that the Government of The United States of America shall recognize that the "Private Attorney Generals Across America" association shall have the authority of representation of the States of the Union within the States of the Union in the capacity of a private attorney general representing and on behalf of resident aliens and documented American Nationals within the States of the Union if so desired by resident aliens and documented American Nationals within the States of the Union, and

**WHEREAS**, the assembly of Affirmed American Nationals have addressed all issues and resolutions on the agenda file name 20160905-Agenda for Assembly;



**BE IT RESOLVED**, the meeting for the assembly adjourned on the **170<sup>th</sup> day, in the year of Yahweh, six thousand and eighteen, translation 5<sup>th</sup> day of September, two thousand and sixteen, at 4:00 Universal Time -6** to re-convene at a future date certain.
