INTERNATIONAL PUBLIC NOTICE

REF: 'Uniting and Strengthening America by Providing Appropriate Tools Required to Intercept and Obstruct Terrorism (USA PATRIOT ACT) Act of 2001'

IT IS NOTICED, that the USA Patriot Act is a clear violation of the positive Law of Nations; voluntary, the conventional, and the customary.

The natural law by and between the States of the Union was presumed to be a federal constitution of the United States when in fact it is the Articles of Confederation of 1781 that's still in full force and effect today as amended August 5th, 2015. After the events of September 11th, 2001 occurred, the U.S. congress proceeded to pass the aforementioned act where its title is listed within the reference of this International Public Notice.

Due to the fact that the constitution of the United States remains at a voluntary level for over 200 years rendered the compact agreement voluntary in its inception and therefore any USA Patriot Act of 2001 or any other act passed by the U.S. congress by the U.S. territory internal revenue trust would not be considered binding in anyway within the States of the Union within The United States of America.
