The grounds for this international order include but are not limited to acts committed by many implementing multiple attacks on civilians under the law of armed conflict and displaying multiple counts of contempt for the Law of Nations, and

INTERNATIONAL ORDER FOR DISSOLUTION

Due to multiple counts of contempt for the Law of Nations,
IT IS ORDERED that the 527 organization known as the Democratic Party is hereby under involuntary dissolution. All former members of the Democratic Party are hereby internationally classified as enemies for multiple counts of political persecution, domestic terrorism, international terrorism, and contempt for the Law of Nations, and

INTERNATIONAL ORDER FOR INVOLUNTARY EXILE

IT IS ORDERED, that William Jefferson Clinton, Hillary Diane Rodam Clinton and Chelsea Clinton are hereby involuntarily exiled for multiple human rights violations against the country of Haiti, multiple international crimes of child trafficking, multiple murders, drug smuggling, pedophilia, and other international crimes too numerous to mention, and

IT IS ORDERED, that all personnel that were hired to act as INFRA-GUARD are hereby relieved of duty immediately, and


AUTHORIZATION
