**WHEREAS**, the National assembly of General Post Masters have addressed all issues and resolutions on the agenda file name 20180226-Agenda for Assembly;

**BE IT RESOLVED**, the meeting for the assembly adjourned on the 344<sup>th</sup> day, in the year of Yahweh, six thousand and nineteen, translation 26<sup>th</sup> day of February, two thousand and eighteen, at 9:30 Universal Time -6 to re-convene at a future date certain.
