# THE SOVEREIGNTY RESTORATION ACT OF 2018

By the authority of the faith of the assembly of American Nationals, in Union under the Law of Nations, and all Acts, petitioned, accepted and acknowledged by the current United States, in Congress assembled, are hereby ordained for the safety and security of our posterity, enact the following on the 1<sup>st</sup> day of October, 2018.

## SUBJECT MATTER OF THE STATUTE ENACTED

It is a crime under the Law of Nations for one sovereign country to attempt to regulate another. However, if this crime is committed against a sovereign country, the sovereign country being invaded has the right to defend itself from such usurpation. Any country willfully subjecting another to its regulations through its agencies or by any other means shall willfully, by consent and intentionally subject itself to the regulations and jurisdiction of the country suffering the tort of invasion, and

**BE IT ACCEPTED AND ACKNOWLEDGED**, by the committee of the National assembly on the 1<sup>st</sup> day of October, 2018,

### REGULATIONS-PENALTIES OF THE STATUTE ENACTED

**1:** If an agency or officer of said agency attempts to regulate, profile, arrest, or otherwise subject any affirmed American National or declared resident within The United States of America shall subject the offending agency to the regulations of the Government of The United States of America. Psychological Warfare is an international crime.

**1A:** Regulation: In the case of refusal to comply with the agencies own consensual political decision, it shall suffer immediate dissolution due to its public proclamation that it is incompetent to regulate itself, incompetent to direct itself in accordance with the Law of Nations, and has witnessed against itself that it is a danger to society.

**2:** In the matter of another sovereign country in violation of the Law of Nations within the subject matter of this act; the leader of said country has committed the most heinous crime against the Law of Nations, and therefore has subjected the leader of the offending country to the regulations of the Government of The United States of America.

**2A:** Regulation: The leader of the offending country will be noticed of the offense and offered time to resolve the offense of the trespass on a foreign Bilateral Social Compact Agreement. If the leader of the offending country ignores the notice, the leader of the offending country shall suffer the dissolution of all of its entities within The United States of America immediately when identified as being an entity of the offending country.

**2B:** This act is hereby extended to all local, state, federal, private membership associations, universities, or other entity that is foreign owned and or operated within The United States of America.
