IT IS DECLARED, that the State of Nebraska of the year eighteen hundred and sixty seven hereby exists within the following metes and bounds to wit:

**State of Nebraska (State hood: March 1, 1867; 37th State) (no metes and bounds found)
State of Nebraska is bordered by State of South Dakota, State of Iowa, State of Missouri, State of Kansas, State of Colorado, and State of Wyoming, containing approximately 77,353 square miles.**

IT IS FURTHER DECLARED, that the State of Nebraska shall exist within the metes and bounds and seaward boundaries of The United States of America as surveyed and established within the Articles of Confederation, as amended the fifth of August, two thousand and fifteen, and

IT IS FURTHER DECLARED, that the official mailing location of the State of Nebraska shall be Natural Area Code: 6N7BW PWFVD, latitude and longitude 41.49253,-99.90182, and

IT IS FURTHER DECLARED, that the Constitution of the State of Nebraska of the year eighteen hundred and sixty seven shall be the Constitution of the State of Nebraska and that all Nationals of the State of Nebraska also known as American Nationals shall be bound thereof in accordance with the Law of Nations, and

IT IS FURTHER DECLARED, that the State of Nebraska shall be a perpetual member of the original Union of the year seventeen hundred and seventy four as amended the fifteenth of May, two thousand and seventeen for the purpose that the State of Nebraska and the Nationals thereof shall not be land locked wherein the metes and bounds and seaward boundaries of The United States of America shall be a part of the National boundaries of the State of Nebraska, and
