Official Assembly Record

BE IT RESOLVED, that a motion was carried by the National assembly to re-value the Continental Dollar legal tender version to the following exchange values:

- One Continental Dollar for one troy ounce silver.
- 20 Continental Dollars to one ounce of gold.
- One Continental Dollar for one bit coin based on 16 million Continental Dollars in existence when bit coin has 16,366,275 BTC in existence.
- One Continental Dollar stamp equals one troy ounce silver

WHEREAS, the assembly of Affirmed American Nationals have addressed all issues and resolutions on the agenda file name 20180122-Agenda for Assembly;

BE IT RESOLVED, the meeting for the assembly adjourned on the 309th day, in the year of Yahweh, six thousand and nineteen, translation 22nd day of January, two thousand and eighteen, at 9:19 Universal Time -6 to re-convene at a future date certain.
