International Public Notice

LETTER OF ASSUMING AUTHORITY OVER THE POST OFFICES AND POST ROADS

Reference: Authority over the Post Roads and Post Offices

Wherein does it read: "Article I, Section 8, Clause 7 of the United States Constitution, known as the Postal Clause or the Postal Power, empowers Congress "To establish Post Offices and post Roads". ... routes and construct or designate post offices, with the implied authority to carry, deliver, and regulate the mails of the United States as a whole."

In accordance with the claim of First in Time, first in right published on 10-13-2016, the above clause is notwithstanding, and

Therefore, the General Post Office of the Government of The United States of America hereby assumes all authority over all Post Offices and post roads....routes for the purpose of the delivery of the mail within the States of the Union and all other post Roads that may be required for efficient mail delivery, and

Further, The UPU was created in 1874, initially under the name "**General Postal Union**", under the Treaty of Bern signed on October 9, 1874. Four years later, the name was changed to "Universal Postal Union".

Further, the aforementioned Treaty is notwithstanding due to the fact that the country never signed the treaty and therefore is not withstanding within the States of the Union nor The United States of America, and

Further, all Zone improvement Plan surveys shall be changed to the appropriate Natural Area Code thereby bringing back the International Jurisdiction to the States of the Union. Any form of domestic jurisdiction is notwithstanding, and

The U.S. Senate is in need of signing a letter of acceptance and acknowledge of this correction of the international record in order to avoid multiple international human rights violations against the people of the States of the Union, and

All debts and obligations contracted by the United States Postal Service is notwithstanding under the General Post Office of the Government of The United States of America, and

The employees of the United States Postal Services shall be inducted into the General Post Office and will not lose their jobs nor benefits upon the determination of the office of the Post Master General of the Government of The United States of America, and

The General Post Office will issue the Continental Dollar Stamp thereby restoring a Nationality to the people of the States of the Union. Many changes will be made to the methods mail is delivered in order to streamline the way the mail delivery service operates within The United States of America and the General Post Office. All international mail will be re-routed away from Manhattan Island, and



The General Post Office welcomes the experienced postal workers with open arms and is looking forward to working with all of them to carve out a better future for everyone if they so choose to continue to deliver the mail.
